



**Sovereign Sustainability Ambition (SSA)
Framework**

Classification of countries

Eurizon Capital SGR S.p.A. (hereinafter also the “Company”) has developed an internal methodology known as the “Sovereign Sustainability Ambition (SSA) Framework.” This framework enables a bottom-up analysis of sustainability factors through a detailed, country-by-country assessment to define the investable universe for products that invest in government, supranational, and agency issuers. Updated at least annually, the methodology classifies countries into four categories: “Most Advanced Countries” (“Achieving Countries”), “Improving Countries,” “Conservative Countries,”—all eligible for investment—and a fourth, non-investable category known as “Laggard Countries.”

Financial instruments issued by supranational entities undergo a specific evaluation by the Company to determine their appropriate classification. Instruments issued by government agencies (“Agencies”), however, are assigned to the same category as their corresponding reference country.
