Investment / Performance Objectives & policy

The fund mainly invests in Japanese government bonds denominated in Japanese yen. The fund generally favours direct investment but may at times invest through derivatives.

Specifically, the fund normally invests at least 80% of total net assets in debt and debt-related instruments, including money market instruments, issued by the Japanese government and denominated in JPY. The credit rating and duration of securities are usually consistent with those of the benchmark.

The fund may invest in the following asset classes up to the percentages of total net assets indicated: - corporate and non-Japanese debt instruments: 20%

The fund does not invest in asset-backed securities or contingent convertible bonds (coco bonds), but may be indirectly exposed to them (maximum 10% of total net assets).





Contribution to Duration by Maturity


